Letter from the President

Greetings Idlewilders,

Spring has arrived in Idlewild. Unfortunately, what little snow there was over the winter is long gone. Because of this, moisture conditions in Idlewild and the surrounding areas are DRY. The National Weather Service's seasonal outlook for the next three months (March 15th to June 30th) is for persistent drought conditions. All of northern New Mexico is in an extreme drought condition. Because of this, Colfax County has issued a burn ban. The use of "exterior fireplaces, stoves, chimeneas, or charcoal briquette barbecues (except for gas-propane stoves and barbecues) and all open flames are prohibited. Chainsaws will be permitted provided the manufacturer's spark arrestor is in place. No burn permits will be issued at this time, and any current burn permits are hereby revoked." Additional information and updates are on the Colfax County website.

The dry conditions have decreased the natural food supply for wildlife. When you are in Idlewild, be aware that your furry neighbors are out looking for food. Please do not leave food or trash outside or in vehicles. Bears will break into vehicles to retrieve a snack. Please dispose of trash properly in the dumpsters in Eagle Nest.

Speaking of trash, let's talk trash.

The Eagle Nest Village Council reviewed the solid waste disposal fees at the March council meeting. Goose was notified and invited to attend the meeting. An interesting factoid is that last year was

the first year that the fees covered the cost of trash disposal. The Eagle Nest solid waste program has been in the red for many years. Goose advised the council that Idlewild residents have the following concerns regarding trash disposal:

- Idlewild residents are paying a higher fee than Eagle Nest residents;
- Idlewild resident are, with a few exceptions, seasonal residents;
- The tickets for disposal of six square yards at the Village dump were removed from the program; and
- The scheduled "free" days at the Village dump do not include any times when residents are in Idlewild.

There was discussion regarding these concerns. It was noted that the six free yards were taken away from Eagle Nest residents as well as those in Idlewild. Mayor Richard Cordova also stated that the fee is not based on the volume of solid waste but is a yearly fee for solid waste disposal. The mayor noted that the fee is part of the cost of owning property. A motion was made and passed to bring the Idlewild solid waste fee down to the same rate as that of the village residents. Future increases of the solid waste fee are tied to the

Consumer Price Index. There was discussion about scheduling a "free" date at the Village dump in June or July. No date has been scheduled at this time.

As part of our effort to go electronic and save our limited funds for important things like road repair and maintenance (please see Skip Johnson's "Update on Roads" in this newsletter), we have set up a Paypal account for payment of the annual assessment. If you have not sent in your assessment fee, please navigate to the website www.idlewildcommunity.org and click on the appropriate link to make your payment via Paypal. There is also a form to update information for the Idlewild Directory. We appreciate your support.

I'm looking forward to a fun-filled summer in Idlewild. Kim and Goose were instrumental last year in bringing back Game Night on Thursdays at the Community Center. Game Night will be back this year. Please join us in fun and frivolity and, on a clear night, in stargazing with Goose's telescope.

Safety First

After the first year of being your caretaker, I want to thank the Idlewild community for all your support. It has been a tremendous year with a huge learning curve and opportunity to get to know you. In this issue of the Goose Report, I would like to focus on the safety of our community.

Fire Safety

Since the weather this year has been different from last year's, I have had the opportunity to get a lot more roadwork and cabin work completed. Even though the lack of snow has allowed me to do more work, it has created a very dangerous fire situation. As it appears now, we will be in extreme fire conditions throughout the summer. Since safety is a priority, our community is going to undergo a review with the fire marshal; within the community we are developing egress maps for each road. At times, we will have to restrict travel on certain roads to ensure fire and emergency access, particularly when we have group gatherings.

Extreme Fire Conditions

Because of extreme fire conditions, we all need to be diligent in our behaviors. There will be *no* outside burning of any kind; that includes open barbecue grills, firepits, smoking outside a vehicle or structure, and driving off roads. There can be no outside welding or use of chain saws or lawnmowers. Fireplace ashes have to be put into metal containers that have a metal air-tight lid. They cannot be dumped or buried in the ground. With fire danger so high, do not drive off dirt roads. A fire can be caused in tall grasses from the catalytic converter in your vehicle. There have

already been several fires in Eagle Nest due to careless behaviors.

Cabin Safety

Another safety issue that needs to be addressed from the homeowner's perspective is cabin safety. It is important to have carbon monoxide and smoke detectors in each cabin and have the cabin evaluated for fire safety for such things as overhanging branches, excessive pine needles around foundations, and firewood stored in inappropriate locations around the house. If you ignore these procedures, you run the risk that the fire crew will

not make an effort to save your cabin in an emergency. If you have any questions, please call me so that I can work with you to develop safety plan for your cabin. ***Community Safety***

We have had a couple of issues with cabin owners hiring contractors and those contractors hiring subcontractors who have not been vetted. There were several issues when untrustworthy people were in our community and thefts occurred. For the safety of all Idlewild cabins, please notify me about work being done so that I can be aware of who is in Idlewild. I have a list of contractors, plumbers, and electricians who have been vetted and who I can recommend if you need work performed on your cabin.

Road Safety

As always, one of the major concerns of all the residents is speeds on the roads and on the roads being maintained. The lack of snow this winter has allowed a lot of progress to be made on many roads, especially on Roads 9 and 15. We also have been working with the state to clean and evaluate all culverts on state and Idlewild roads and to develop a road plan to repair some of the worst roads that have high traffic and safety issues. Also, watch your speeds while driving. When people drive on our roads at high speeds, they destroy the roads, causing washboard conditions and road erosion around corners and in other places. If you would like to know more about future road plans, please contact me. Your input is highly valued.

Animal Safety

Because of our mild winter and the lack of nuts and berries, bears and large cats are on the prowl. We need to use extreme caution with food, trash, and bird feeders so as not to draw wild animals into the heart of our community.

Again, thank you for your tremendous support during my first year as caretaker. Kim and I appreciate your kindness. We welcome you to visit the caretaker's cabin next time you're in Idlewild. Come enjoy a cup of coffee or a refreshing beverage with us.

Firewise Essentials

I will be updating the **2018 Idlewild Firewise Essentials** paper in the next few weeks. It will again be stored in the **Files** section of our private Facebook Group, **Idlewild, NM**. If you are not familiar with this group, navigate to our website, idlewildcommunity.org, and click on the “FB” symbol on the home page to get to the FB Group. There are **new standards for reporting Firewise activity**, and these will be explained in the 2018 version of the paper. On the group’s home page, there is a column of buttons at the upper left. “Files” is at the bottom. All of the Idlewild files there are in PDF format.

Important Information from the Board!

We have two important additions to this issue of the *Idle Times*, which are shown on the facing page. These two forms will be reproduced on the front and back of a sheet of heavy card stock to be displayed in your cabin:

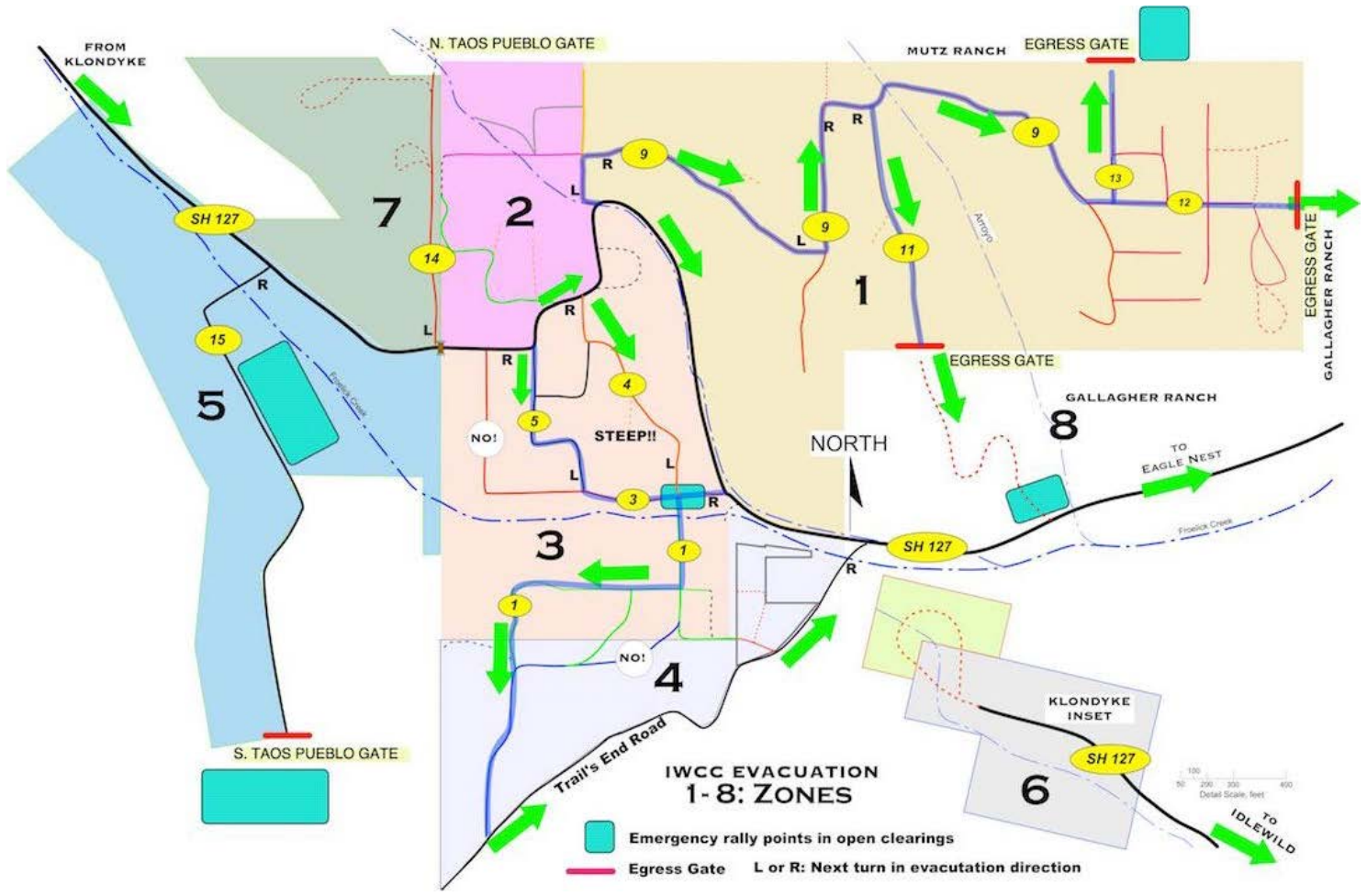
- 1. New Community Guidelines:** The Board of Directors has prepared a new set of Idlewild Community Guidelines. *This replaces any previous versions you may have.*
- 2. IWCC Evacuation Map:** The map has been designed by Goose, Fire Chief Scott Gibson, and Frank Ray, with generous cooperation and support from our neighbors, the Mutz and Gallagher ranches and the Taos Pueblo. It shows the most feasible routes that can be used to escape the community if a wild fire should break out. Any of the routes highlighted on the map will take you to a safer area. Gathering areas are noted in several places. Be aware that it may be impossible to go directly down Highway 127 toward town; emergency vehicles may commandeer the highway if necessary to fight a fire. Read “The Goose Report” in this newsletter for further information on plans for fire safety.

Goose and Kim have kindly offered to deliver the cards to all cabins in the community. We expect the new cards to be printed by June and distributed by the summer. If you do not receive yours in a reasonable time, please contact Goose or Kim.

IDLEWILD COMMUNITY GUIDELINES

1. Please respect your Idlewild neighbors. Cabin owners are responsible for their pets and for actions of their guests. New guests will need to be informed.
2. Outside fires and trash burning are never permitted.
3. ATV/OHV use will be confined to established community roads. Keep off private property and driveways, especially on Pueblo and private ranch lands that surround Idlewild. Also, vehicles must be registered in New Mexico.
4. Fireplace ashes should be stored in a metal container until COLD and then discarded in dumpsters or the village dump.
5. Keep roofs, gutters, chimneys and stovepipes free of all flammable materials and remove branches from above chimneys and stovepipes. All flammable materials on the ground must be more than 3 feet from cabin walls and not allowed to accumulate near flammable siding.
6. No mobile home, trailer, tent, or other temporary living quarters are permitted except for use during construction of permanent housing.
7. All garbage, trash, etc., must be put in dumpsters in Eagle Nest. The village prefers that we use the dumpsters across the street from the Village Offices where there are also assorted recycling bins. Non-household trash is to be taken to the village dump on the road to Red River.
8. Use of firearms, compressed air firearms, and fireworks is not permitted.
9. Outside noise ---vehicular or power tools, etc.--- is not permitted during the worship hour (10:30 –11:30 a.m.) on Sundays from Father's Day through the Labor Day weekend.
10. Do not feed any wildlife. A fed bear is a dead bear. New Mexico Game and Fish can fine you up to \$500.00 if a bear eats whatever food you might have put outside.
11. When calling 911, give the cabin owner's name, road number and cabin number. If available also give the ERA Zone (1–8) number found on the Idlewild map and in the Idlewild Directory.
12. Cabin Owners: Please post your name and Idlewild address close to the phone for possible guest 911 calls. For example, 24 Rd 6 is House 24, Road 6.
13. Make sure your official reflective Firewise address sign (house number only) has been properly installed near your driveway. The caretaker can assist with this project.

Update on Roads

One of the primary, some would say the most important, IWCC board functions is maintenance of our roads. Rain and snow can be both a blessing and a curse. Insufficient moisture leads to drought and all the unpleasant things that come with it; however, too much moisture is harmful to dirt roads. Abundant rain and snow are, for the most part, not a problem *except for dirt roads*.

Our road system truly suffered this past year. After an abundant snowfall during the 2016–2017 winter, the precipitation simply *did not* quit: *rain, rain, rain, more rain, much more rain!* The extremely intense summer-2017 rains were quite unusual and the result of thunderstorms losing their forward motion, becoming stationary, and raining out without further movement. At one point in early August it rained so intensely that the main road (Hwy. 127) washed out at a couple of lengthy places between the caretaker's cabin and the Mixon cabin. Thankfully, our caretaker, Kevin Jarigese, was on duty and got the situation stabilized until the county could re-grade that section the following day. Now, it is generally not a good thing to complain about rain, but this past year there was much more precipitation than our roads could handle.

The board takes road conditions and maintenance as a serious matter. Cabin owners should be able to travel to their cabins over reasonably maintained country dirt roads. Road maintenance is a significant portion of the IWCC annual budget. With the frequent and intense rains, hiring a contractor to apply materials to our roads this past summer would have been like burning dollar bills.



In a normal year, the Road Committee generally reviews roads each year after the April mud season and performs necessary maintenance (grading, spreading gravel, filling holes, etc.) so that the roads are generally in good shape for the start of the summer season around Memorial Day or the first part of June. Depending on summer rainfall, additional maintenance may be required, to be performed as is necessary and as our funding allows. Our funding comes from IWCC cabin and property assessments, which also must cover our other community needs (caretaker, community property, insurance, etc.). This past winter has been extremely dry with no significant snowfall. Recognizing that this last year was not typical of the past several and knowing our budgetary constraints, the board has initiated several steps to help the road situation. Following the winter, we plan to initiate our normal road

maintenance plan so that roads are in good shape by the Memorial Day holiday.

Kevin has made good use of the unusually dry conditions to make several road improvements. He has had material deposited at several locations around Idlewild and has used his equipment and had a contractor assist in making significant improvements to several locations. Of particular note are Roads 15 and 9. We were in danger of washing out the Froelich Creek culvert on Road 15 near Highway 127. The road there has been completely reworked, the culvert reset, and the roadway elevated to prevent water overflowing Road 15. This should eliminate the virtually constant wet areas on Road 15 near the creek.

As of this writing, a significant amount of work has been performed with more planned on Road 9 from the intersection with Roads 8 and 10 to the culvert across Road 9 near the intersection with Road 11. Several places along this stretch have been improved with the additional work to be done shortly if the dry weather holds. Kevin deserves kudos for developing and fostering a good relationship with Nate Kite and for working with Nate to get a significantly reduced equipment rate for working on some of the stretches of both Roads 15 and 9 where heavy equipment was, and will be, needed to make the necessary improvements. Nate Kite also deserves our thanks for his company's assistance to Idlewild.

How can YOU help?

All of us can help to minimize maintenance on both our roads and our individual driveways. Two keys are to watch your speed and where you drive. Well, the first is obvious. Excessive speed is damaging to roads and your vehicle (not to mention to kids who may be playing in or near the road). The second should be obvious to all who have lived in an area with unpaved driveways. If you continuously drive along exactly the same track, your wheels will begin to create small ruts in an unpaved roadway or driveway. With a little rain and continued driving in the same tracks, potholes are formed and grow larger with time. So don't drive in exactly the same track all the time. Just move slightly to the left or right. It's just common sense and it will help the roads and your driveway.
